MUNICIPAL STAFFING AND PROGRAMS



STAFFING

- Staff required to work from home if at all possible
- 248 staff impacted by layoffs (casual, contract, part-time)
 - 23 on leave since April 2020
 - 205 currently on infectious disease emergency leave
 - 20 to go on leave January/February
- Continuous review of redeployment needs and possibilities to support operations
- Enforcement of screening & masking protocols where presence at workplace is required



MUNICIPAL SERVICES

- Town of Aurora approach: balance health and safety with quality of life
- Maintained vast majority of municipal services
- Focused on innovation and new ways of doing business
- One of the only municipalities that has maintained special events programming



CURRENT REGULATORY FRAMEWORK



2020 DECLARATION OF EMERGENCY

- Made on March 17, 2020 pursuant to the Emergency Management and Civil Protection Act
- Aurora also declared on the same day
- Provincial state of emergency was terminated July 24, 2020 under Reopening Ontario (A Flexible Response to COVID-19) Act, 2020
- Aurora's declared state of emergency remains in effect

9	Close playgrounds and parks	Director delegated authority in Parks By-law No. 4752-05.P	To ensure children do not play on unsanitized playgrounds; To respect the social distancing and social gathering rules and assist in flattening the curve

2021 DECLARATION OF EMERGENCY

- Made on January 14, 2021
- Allowed the province to issue new orders, including the Stay-at-Home Order
- All existing orders remain under the ROA and may be amended
- Stage 1 Order amended



STAY-AT-HOME ORDER

Permitted purposes include:

- 1. Work/Volunteer, school and childcare
- 2. Obtaining goods and services
- 3. Assisting others
- 4. Health, safety and legal purposes
- 5. Multiple residences and moving
- 6. Travel
- 7. Gatherings
- 8. Animals



RULES FOR AREAS IN STAGE 1 ORDER

- General Requirements, including public health measure and capacity limits
- Retailers, including big box and discount stores, that primarily sell food – open
- Other Retailers curbside pick-up or delivery only
- Restaurants open for take-out, drive-through or delivery only
- Services many still permitted, including, those that promote health care and social services or are to support children, seniors or vulnerable persons or necessary for the health and welfare of animals



RULES FOR AREAS IN STAGE 1 ORDER (continued)

- Community Centres
- Construction Projects
- Outdoor recreational amenities
- Public libraries curbside pickup and return of materials; may open to provide social services
- Refer to Order for all businesses or services that may open and with what conditions or restrictions

RULES FOR AREAS IN STAGE 1 ORDER (continued)

- Organized Public Events or Social Gatherings
 - Indoor events or social gatherings not permitted
 - Indoor wedding, funeral or religious service, rite or ceremony permitted – 10-person limit and physical distancing rules apply (unless gathering is in a motor vehicle)
 - Outdoor events or social gathering permitted up to 5 people, with physical distancing



COMMUNITY SERVICES IMPACTS



FACILITIES

- Cost mitigation measures:
 - Removed ice from AFLC and ACC 1 monthly savings of approximately \$10,000-\$12,000 (takes 2 weeks to restart ice)
 - Maintain ice in ACC 2, SARC ability to restart quickly to generate revenue
 - Removed water from hot tub and therapy pool
 - Maintain water in large tanks costly to refill
- Overall measures to reduce utility costs: reduced facility temperatures, turned off lighting where possible, reduced pool temperatures & pump circulation frequency
- Goal: mitigate without impeding ability to start back up quickly as needed



OUTDOOR ICE PADS

- 4 municipal ice pads (maintained by the Town)
 - 2 at Town Park
 - o 2 at Ada Johnson Park
- 2 community ice pads (maintained by local volunteers)
 - 1 at Queen's Diamond Jubilee Park
 - 1 at James Lloyd Park



OUTDOOR ICE PADS (continued)

- All 6 ice pads will follow the same process:
 - Pre-registration, Aurora Residents Only
 - 25 maximum per timeslot (exception: James Lloyd Park)
 - o 45-minute limit
 - Mandatory masks
 - Security detail to monitor compliance
- Outdoor skating is permitted within the Order; no capacity limits but 2m physical distancing is required and no team sports or games are permitted

PROGRAMS AND EVENTS

- Continue to offer virtual programs, but have now moved and adapted more of the in-person programs to virtual
 - What's Cooking
 - Creative Projects
 - Exercise at Home
 - STEM activities
 - Themed Take Home Kits
 - Virtual Tours places locally and around the world
 - Preschool, Children's, Youth, Adult and Seniors Activities

EMERGENCY WARMING CENTRE

- Under the current provincial orders and public health regulations,
 Emergency Warming Centres are an essential service.
- The Town's Emergency Warming Centre, located at the SARC, will be activated whenever York Region issues an Extreme Cold Weather Advisory
- The Centre will be operational from 10 a.m. to 9 p.m., seven days a week, during any Extreme Cold Weather Advisory



ENFORCEMENT IMPACTS



BYLAW ENFORCEMENT OPERATING PARAMETERS

- Enforcement efforts will be focussed on non-compliant businesses and outdoor social gatherings above the limit of 5 people
- Under the declaration of Provincial Emergency Municipal Law Enforcement Officers have authority to:
 - Require ID if reasonable grounds to believe an offence has been committed
 - Temporarily close premises where event or gathering exceeds the limits under Reopening Ontario Act
 - Disperse crowds or groups where non-compliance is observed
- If voluntary compliance is not achieved Bylaw Services will require Police assistance.
- Cannot enforce stay-at-home order due to lack of enforcement framework in place and individual judgment for leaving residence



REGIONAL COORDINATED ENFORCEMENT EFFORTS

- A Regional Task Force was established at the onset of Covid-19 with the objective of having a consistent and coordinated approach to enforcement across the region
- All 9 Municipal Bylaw units participate in Regional COVID-19 Task
 Force as well as other government agencies including Police, Public Health, Ministry of Labour, AGCO and others
- Task Force meetings weekly to address issues and coordinate enforcement activities
- Proactive blitzes and joint inspections are conducted
- Weekly reports on inspections and charges provided to the Region and to Ministry of the Solicitor General to support guideline and restriction decisions



WRAP-UP & NEXT STEPS



FINANCIAL IMPACTS

- All municipal programs currently operating within budget despite COVID-19 impacts
- Financial impacts to be shared in forecast report in June
- 2020 impacts were mitigated within operating budget
- Safe Restart funding received to date = \$1,847,500



COMMUNICATIONS

- Extremely active communication program during COVID-19
- Used variety of tools: social, web, print, advertising, signage, media products, infographics, Engage Aurora
- 100's of social media posts, with an initial reach of approximately 25,000 each post
- Active participation in regional communications task force to coordinate messaging across region



NEXT STEPS

- Continued flexibility to adapt to changing circumstances
- Committed and dedicated staff team
- Active collaboration with Region and municipalities within region
- Ongoing dialogue with Council to provide updates
- Supporting regional vaccination program roll-out



REGIONAL VACCINATION PROGRAM

- Vaccination program to be led by Regional public health units
- Municipalities invited to support vaccination clinics by providing staff to be deployed
- Deployment dates: February to December, three-month minimum
- Full-time and part-time deployments available
- Offer extended to Town of Aurora employees to express interest
- Municipal operations take priority over deployment

COVID-19 UPDATE

LOCKDOWN RULES

IN ONTARIO



ONLY LEAVE YOUR HOME FOR ESSENTIAL TRAVEL



Grocery, Gas & Pharmacy Shopping
Pick-up, take-out or drive through from restaurants
Accessing health care services
Exercising outdoors & walking pets
Assisting others in need of support
Accessing child care
Caring for your pets
Going to a bank

GATHERINGS

Limit contact to only your household members
If you live alone, you can gather with one other household only
Five people can gather outdoors - keep a 2-meter distance
Wear a face mask or face covering indoors and outdoors
Attend a funeral, religious service or wedding with up to 10 people

Non-essential construction, including belowgrade projects, will be limited



SHOPPING

Non-essential stores can only provide curbside pickup or delivery from 7 a.m. to 8 p.m.

Restrictions do not apply to stores that sell food, pharmacies, gas stations, convenience stores and restaurants for takeout and delivery

ENFORCEMENT

Ontario Provincial Police, local police forces, bylaw officers, and provincial workplace inspectors, will have the authority to issue tickets to individuals found in contravention with the stay-at-home order

SCHOOLS

Elementary and secondary schools will be remote until February 10, 2021

Students in Grades 1 to 12 must wear a face mask
