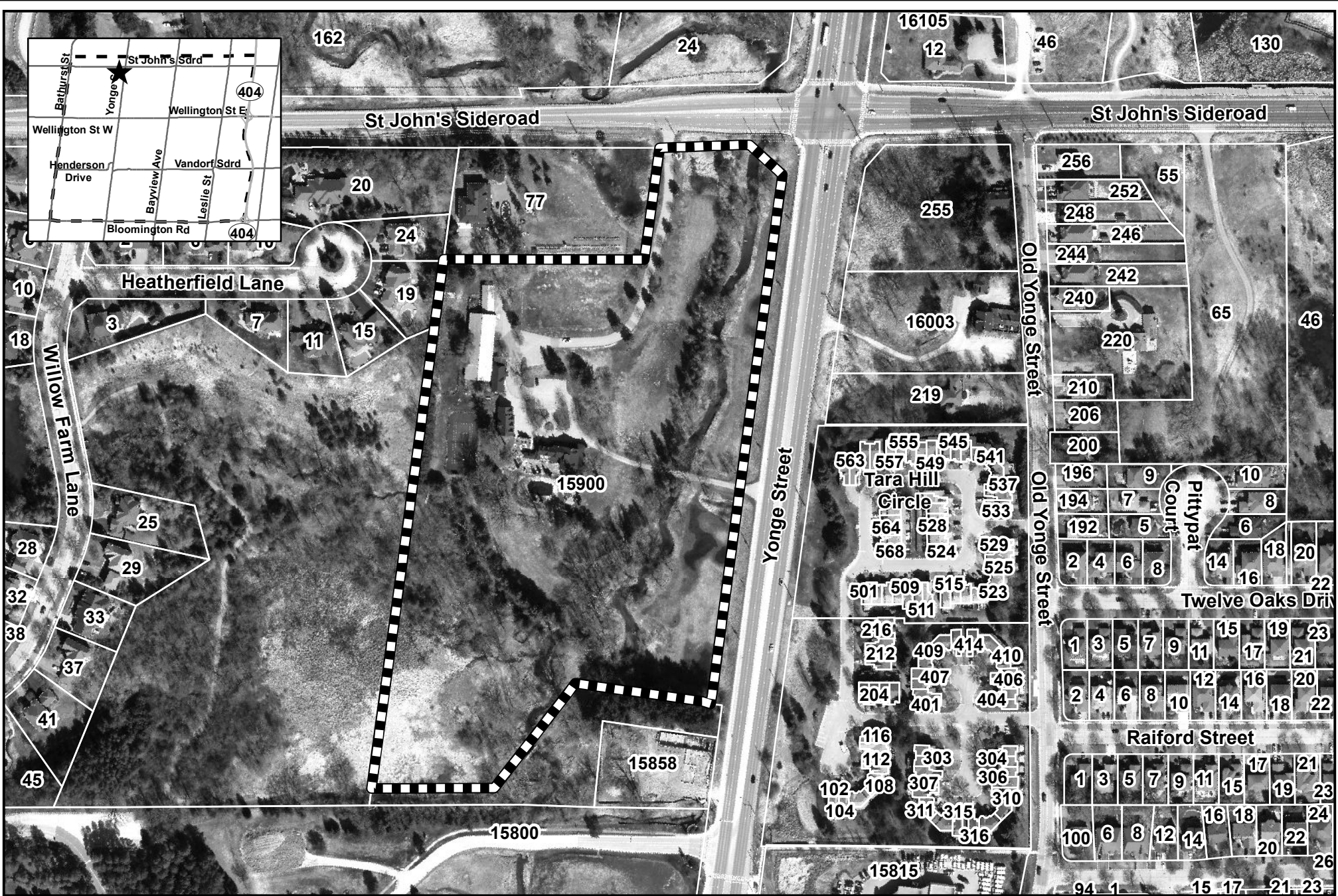

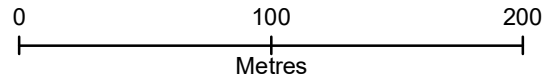
LOCATION MAP

15900 YONGE STREET

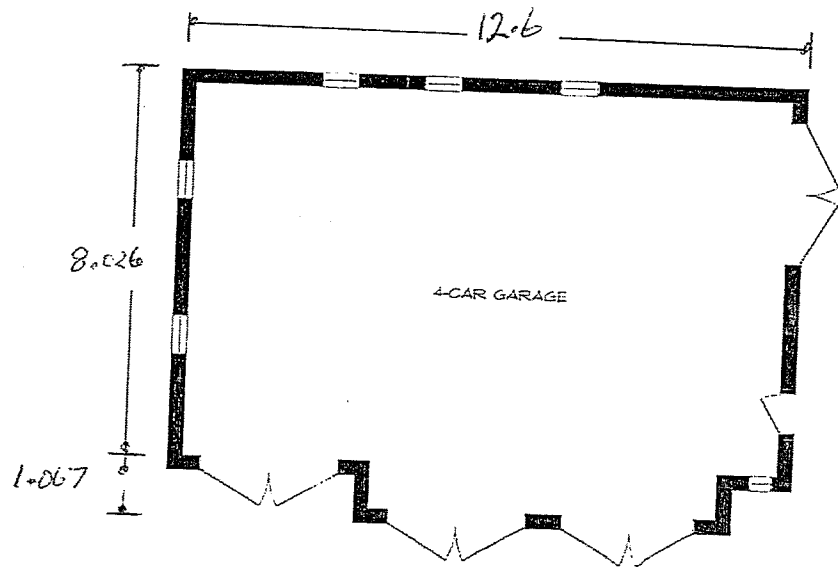

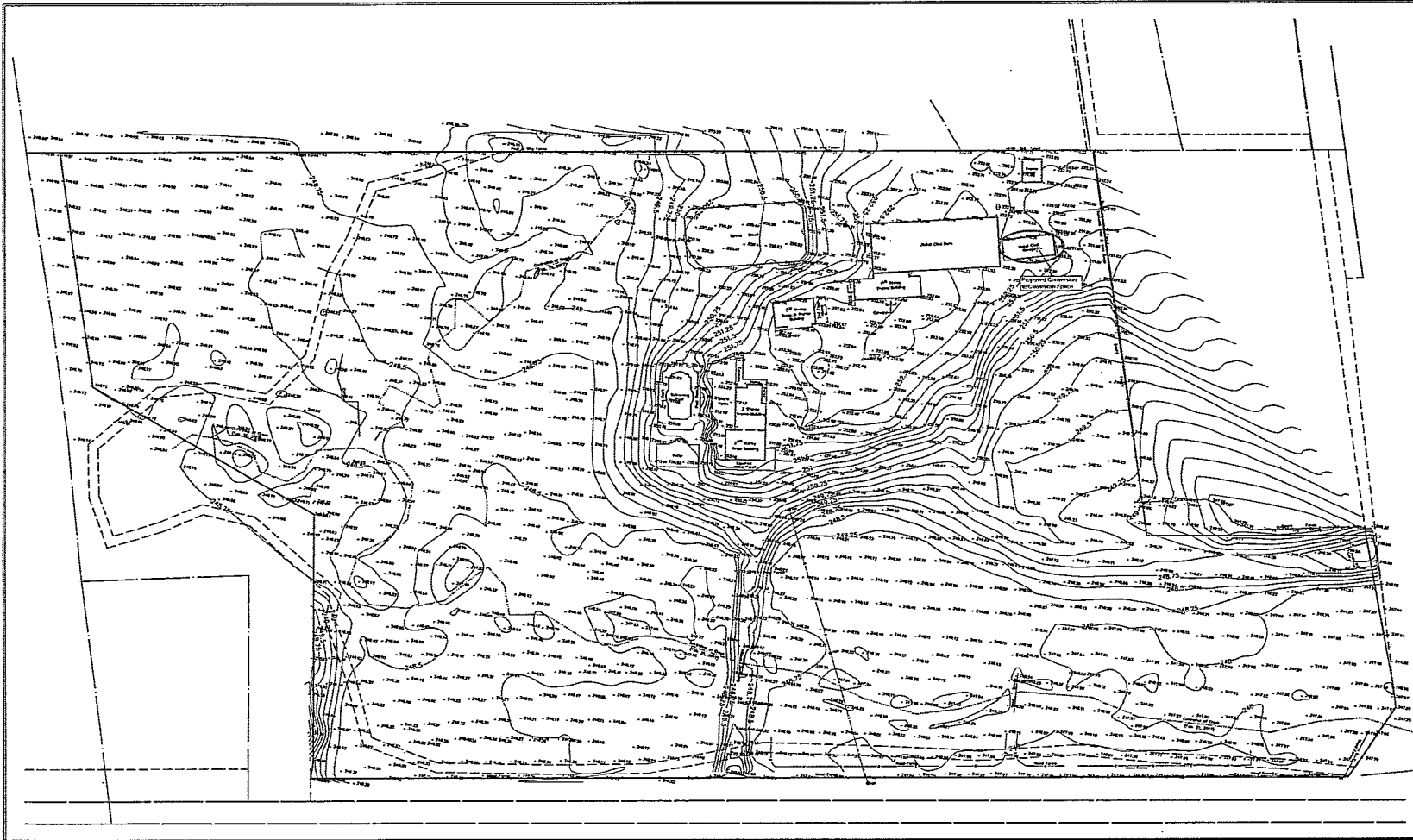
