**PURPOSE:** A Minor Variance Application has been submitted to facilitate an

Accessory Structure and a reduction to the open, landscaped or

natural conditions.

## THE FOLLOWING VARIANCES ARE REQUIRED:

- 1. Section 24.362.1.2 of the Zoning By-law requires a minimum setback of 2.0m from the side lot lines.
  - a. The applicant is proposing an Accessory Structure, which is 1.5 m to the side lot line.
- 2. Section 24.362.1.3 of the Zoning By-law requires a minimum of 50% of the lot area be preserved in an open, landscaped or natural condition.
  - a. The applicant is proposing more than 58% of the lot area as built or covered with impervious material, leaving less than 50% in natural condition.

A Location Map and Site Plan illustrating the request are attached. This Application will be heard by the Committee of Adjustment on the Date and Time shown below.








