THE FOLLOWING VARIANCES ARE REQUIRED:

- 1) Section 24.35.1 of the Zoning By-law does not allow for a Veterinarian Clinic as a use.
 - a. The applicant is proposing a Veterinarian Clinic which is not a listed permitted use in the 24.35.1 zoning

Please note that under the definition of "Veterinarian Clinic", the overnight treatment or boarding of pets is not permitted.

Veterinarian Clinic is defined as "means a Premises where domestic animals or birds, excluding livestock are treated but not kept for overnight treatment or board."


Attachment 1 - Location Map


