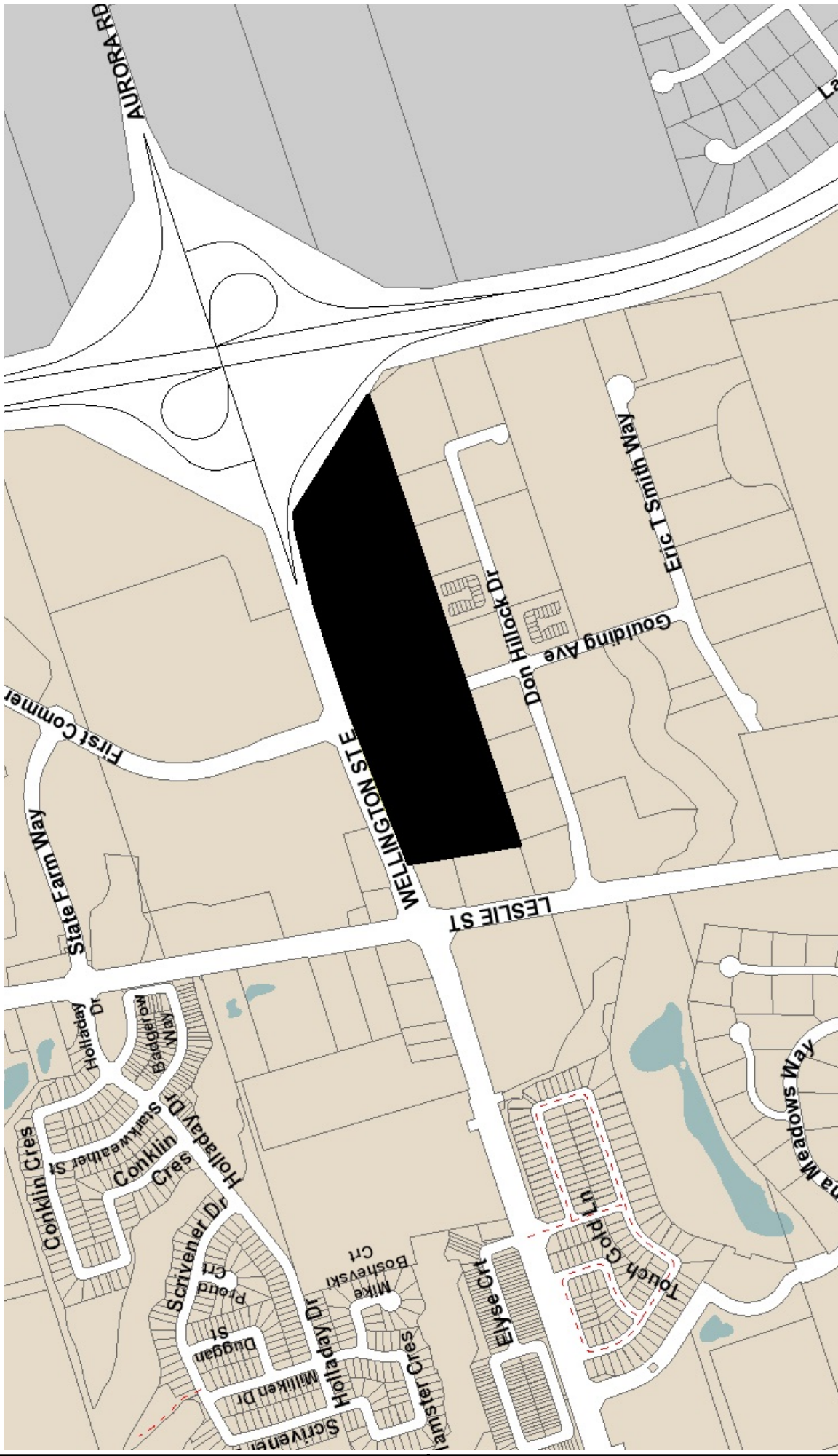

KEY MAP

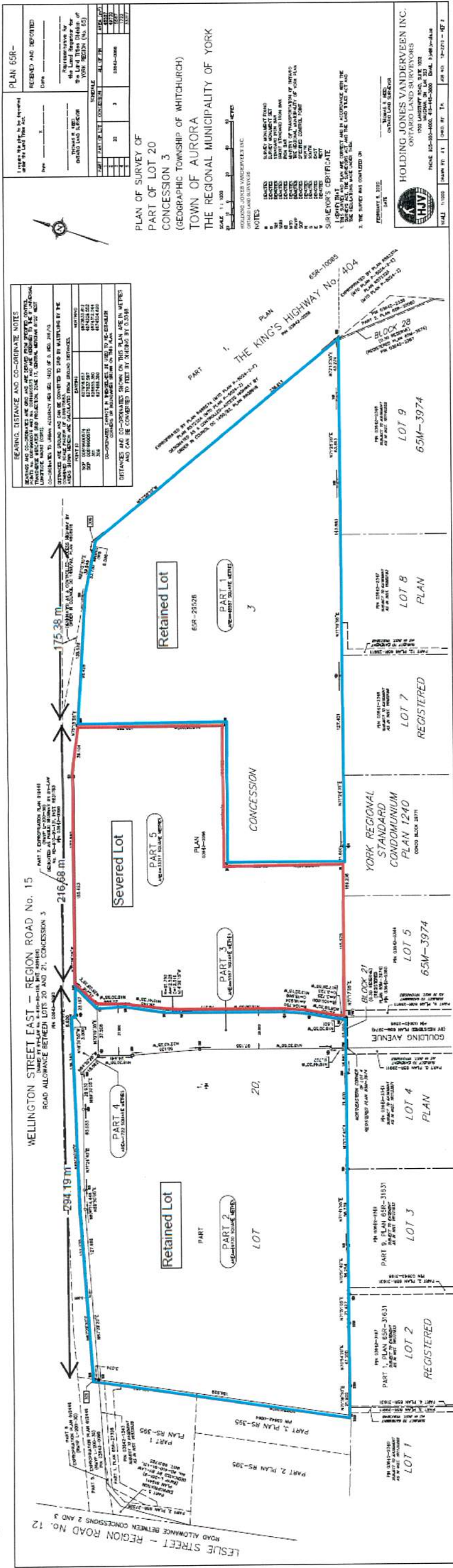
