**ZONING:** Detached Third Density Residential Zone (R3)

**PURPOSE:** The Owner has submitted a Minor Variance Application to allow

reduction for a detached shed and deck platform.

# BY-LAW REQUIREMENT:

- 1) Section 7.2 of the Zoning By-law requires a minimum interior side yard of 1.2 metres;
- Section 4.20 of the Zoning By-law states that eaves may project 0.7 metres into any required yard;
- 3) Section 4.1.1 of the Zoning By-law requires a minimum rear yard of 1.0 metres;
- 4) Section 4.1.1 of the Zoning By-law requires a minimum rear yard of 1.0 metres.

# PROPOSAL:

- a) The applicant is proposing to allow reduction for a detached shed which is 0.3 metres to the side property line; thereby, requiring a variance of 0.9 metres;
- b) The applicant is proposing to allow reduction for a detached shed with eaves projecting 1.2 metres into the interior side and rear yards; thereby, requiring a variance of 0.5 metres;
- The applicant is proposing to allow reduction for a detached shed which is 0.3 metres to the rear property line; thereby, requiring a variance of 0.7 metres;
- d) The applicant is proposing to allow reduction for a detached **shed and** deck platform which is 0.0 metres to the rear property line; thereby, requiring a variance of 1.0 metres.

A Site Plan illustrating the request are attached.
