Executive Summary

This report is to provide Council with information as to what actions were taken between the date the Mayor declared an emergency on March 18, 2020 and the date of the Special Council meeting of March 31, 2020.

 The actions taken by the Mayor and/or staff were authorized by legislation or delegated in Town By-laws.

Background

On March 17, 2020, due to the growing public health concerns surrounding the 2019 Novel Coronavirus (COVID-19), the Province declared a province-wide emergency under section 7.0.1 of the *Emergency Management and Civil Protection Act, 1990* ("EMCPA"). On March 18, 2020, Mayor Mrakas declared a state of local emergency in accordance with the EMCPA in the Town of Aurora. Once an emergency is declared, the Mayor may take such action and make such orders as he considers necessary and are not contrary to law to implement the emergency plan and to protect property and the health, safety and welfare of residents.

As a result of various emergency orders issued by the Province dealing with the closure of various venues and prohibiting organized public events of no more than five (5) people, in-person General Committee and Council meetings were cancelled. On March 19, 2020, the Province enacted Bill 187, *The Municipal Emergency Act, 2020,* which allowed meetings of Council to be conducted through electronic means during declared emergencies, provided electronic meetings were permitted in the municipality's

Procedural Bylaw. On March 31, 2020, Aurora Council held a Special Meeting to amend its Procedural Bylaw for such a purpose. Since then, the Town has been holding regular General Committee and Council meetings via electronic means.

The purpose of this report is to provide information as to what actions were taken by the Town from the date the emergency was declared to the date of the Special Council meeting.
