Executive Summary

This report is a follow up to report CS24-022 - Addition of Illumination Requests to the Town's Flag Policy and provides information on the Town's experience with illumination requests one year into accepting them. The report touches on;

- The Town received and approved 14 requests for illumination at Aurora Town Square in the first year of accepting requests
- There have been no complaints regarding the lighting from illumination requests from the property owners in the area

Background

When Council approved illumination requests to take place at Aurora Town Square, a follow up report was requested to ensure that the lighting did not cause adverse effects to the surrounding neighbourhood.

Analysis

The Town received and approved 14 requests for illumination at Aurora Town Square in the first year of accepting requests

Requests for illumination began to be accepted to illuminate Mirkopoulos Plateia (the Outdoor Square) last October. The following are the approved list of illuminations;

- Purple for National Disability Employment Awareness Month October 17, 2024
- Red for National 211 Day February 11, 2025
- Purple for National Epilepsy Awareness Month March 26, 2025
- Green for World Autism Day April 2, 2025
- Purple for National Dental Hygienists Week April 4, 2025
- Red for Menstrual Health Day May 28, 2025
- Red for Cavernous Malformation Awareness Month June 12, 2025
- Blue for Prostate Cancer Foundation of Canada September 7, 2025
- Blue/Yellow for National Coaches Week September 17, 2025
- Green for World Mitochondrial Disease Week September 20, 2025
- Blue/Purple rotation for National Disability Employment Awareness Month -October 16, 2025
- Blue for World Antimicrobial Resistance (AMR) Awareness Week November 24, 2025
- Purple for UN International Day for the Elimination of Violence Against Women -November 25, 2025
- Red for World AIDS Day December 1, 2025

There have been no complaints regarding the lighting from illumination requests from the property owners in the area

The lights used to illuminate Mirkopoulos Plateia (the Outdoor Square) have not been intrusive to the neighbouring properties. Further to this, staff ensure the lights are turned off by 10-11 p.m. depending on the time of year.
