#### **Information About Preserving Your Appeal Rights:**

The proposed applications were received on May 27, 2025, and therefore, the applicant may appeal to the Ontario Lands Tribunal after the date of September 24, 2025.

If a person or a public body would otherwise have an ability to appeal the decision of the Council of the Town of Aurora to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submission the Town of Aurora before the approval authority gives or refuses approval of the subject applications, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting or makewritten submissions to the Town of Aurora before the approval authority gives or refuses approval of the subject applications, they may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

If you wish to be notified of the decision of the Council of the Town of Aurora on the proposed Official Plan Amendment and Zoning By-law Amendment applications, you must make a written request to the Town to the attention of the Director of Planning and Development Services.

If you have received this notice as an owner of a property and the property contains seven (7) or more residential units, the Town requires that you post this notice in a location that is visible to all of the property's residents.
