solemnly declare that:

1. I am qualified pursuant to the *Municipal Elections Act, 1996* and the *Municipal Act, 2001* to be elected to and to hold the above-noted office.
2. Without limiting the generality of paragraph 1, I am a Canadian citizen, at least eighteen (18) years of age, and I am a resident in the area of jurisdiction of the School Board for which I am seeking office.
3. I am qualified under the Education Act to vote for members of the School Board to which I am seeking office.
4. I am not ineligible or disqualified under the *Municipal Elections Act, 1996*, the *Education Act*, the *Municipal Conflict of Interest Act* or any other Act to be elected to or hold the above-noted office.
5. Without limiting the generality of paragraph 3:
 - I am not an employee of any School Board or if I am an employee of a School Board, I am on unpaid leave of absence as provided for by section 219 of the *Education Act* and section 30 of the *Municipal Elections Act*.
 - I am not a Clerk or Treasurer or Deputy Clerk or Deputy Treasurer of any municipality or upper-tier municipality within the area of jurisdiction of the School Board or if I am such a person, I am on unpaid leave of absence as provided for by section 219 of the *Education Act* and section 30 of the *Municipal Elections Act*.
 - I am not a member of the Legislative Assembly of Ontario or the Senate or House of Commons of Canada or, if I am such a person, I will provide proof of my resignation in a form satisfactory to the Town Clerk prior to 2:00 p.m. on Nomination Day (August 21, 2026). I understand that the Town Clerk will reject my nomination for the above-mentioned office if I fail to provide proof of resignation by this deadline.
6. I am not prohibited from voting in the municipal election under subsection 17(3) of the *Municipal Elections Act, 1996*.

Personal information on this form is collected under the authority of the *Municipal Elections Act, 1996* and will be used for the nomination process for office in the municipal election and will be available for public inspection at the Town Clerk/Returning Officer at the Town of Aurora. 7. Without limiting the generality of paragraph 6:

- I am not a person who is serving a sentence of imprisonment in a penal or correctional institution.
- I am not a person who was convicted of the corrupt practice described in subsection 90(3) of the *Municipal Elections Act, 1996*, if voting day in the current election is less than five years after voting day in the election in respect of which I was convicted.

6. I am not disqualified from being elected to or holding office by reason of any violations of the election campaign financial requirements or violations for not filing the financial statement pursuant section 88.23 of the *Municipal Elections Act, 1996*.

I make this solemn declaration conscientiously believing it to be true, and knowing that it is of the same force and effect as if made under oath and by virtue of the *Ontario Evidence Act*.
