BY-LAW REQUIREMENT:		
	1)	Section 24.151.1 of the Zoning By-law does not include "An apartment building with a maximum of 8 units" as on of the permitted uses;
2	2)	Section 24.151.4 of the Zoning By-law require the location of an accessory structure to be a minimum of 0.5 metres from the northern lot line.
PROPOSAL:		
6	a)	The applicant is proposing to include "An apartment building with a maximum of 8 units" as a permitted use;
t	b)	The applicant is proposing an existing accessory structure

0.24 metres from the northern lot line.
