5.1 Streetscape Design Project Update (Guest) CIMA+

Provided an update on the Streetscape Design project in downtown Aurora (refer to the PDF/PPT).

- The project will redesign the area as a destination where residents/visitors will want to go to walk around and/or socialize as is the case in Lindsay.
- The redesigned downtown will ultimately attract new businesses that appreciate the modern aesthetic and density of foot traffic

Tracy S.: Why does the project stop at Yonge and Wellington?

- Marco R.: The original plan identified that boundary in Phase 1.
- **Nancy Fleming:** The traffic study will extend slightly north of that area.

Bill H.: What is the AEDC Board's role in the process?

Marilee H.: The Board has an advisory role and receives project updates.

Mae K.: What benefits did Lindsay experience after their Streetscape Design?

• Nancy Fleming: To provide a follow-up regarding the economic impact of the infrastructure change/update on Lindsay.

Mayor Mrakas: Will a light canopy be installed as part of the redesign?

• The installation of a light canopy will be reviewed. There is a potential issue regarding the provision of a safe roadway for Emergency Medical Services and their e.g. ladders if/when they drive through the downtown core.
